





Overall level of satisfaction


What is your overall level of satisfaction with LightingEurope?

Please rate the following statements.





We are working towards clarification and simplification of current rules

LightingEurope's requests on PFAS (forever chemicals)

- Did you know that the EU could potentially ban all products containing PFAS, including lighting products?
- If you do not request an exemption for your specific product type, your products may be automatically banned.
- Do you think your products are covered by LightingEurope's requests? We are now updating our list of products for our industry
- Only you know the specifics of your products and can properly defend why an exemption should be necessary



LightingEurope's public statement on Taxonomy + our request to have luminaires included

We are calling for **inclusion of manufacturing of luminaires** as a whole in the EU Taxonomy as enabling activity.

Following a new meeting with the EU Commission in June 2025, a new proposal is being discussed for inclusion

LightingEurope's Statement on EU Taxonomy

Classification of luminaire manufacturing

The EU Taxonomy is a green classification system that translates the EU's climate and environmental objectives into criteria for specific economic activities, for investment purposes.

In its current version, the Delegated Act of the EU Taxonomy which establishes the Technical Screening Criteria (TSC) for determining when an economic activity qualifies as contributing substantially to climate change mitigation or climate change adaptation¹ covers manufacturing of lighting products in activity "3.5. Manufacture of energy efficiency equipment for buildings". Specifically, in this section the manufacturing of light sources and of presence and daylight controls for lighting systems are expressly mentioned among the economic activities eligible for Taxonomy.

The current wording in the Regulation, as described above, does not provide full clarity on the classification of the manufacturing of all lighting products in the EU Taxonomy for climate change mitigation and adaptation purposes, which has created some uncertainty in the market.

LightingEurope believes that it would be beneficial if manufacturing of luminaires as a whole would also be explicitly mentioned as an enabling activity for Taxonomy climate change mitigation and adaptation, with relevant and specific Technical Screening Criteria.

For this reason, LightingEurope is working to help clarifying the wording of the activity definitions, including the Technical Screening Criteria, in view of a possible future amendment of the legislative act.

Criteria to Become a Member



You need:

- To be a manufacturer of lighting products or components of lighting products with offices in at least a country of continental Europe
- To be a member of one of the national lighting associations (unless no relevant association is a member - then 50% increase will apply)
- To have significant R&D activity (no pure importers)
- Only the company ranking highest in the group becomes member

You need:

- An association representing lighting manufacturers at national level in Continental Europe (no regional associations allowed)

Become a member in 2025

A form has to be filled and signed, indicating:

- the Global and European lighting Turnover for companies,
- the Turnover of your members for associations,
- the correspondent Fees, and
- the Working Groups or Group where you want to contribute to.


